

### ADOPTED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF MANDALAY BEACH CLUB OWNER'S ASSOCIATION, INC.

1. Adopted amendment to ARTICLE 3 of the Articles of Incorporation of Mandalay Beach Club Owner's Association, Inc. (the "Articles"), to read as follows:

#### ARTICLE 3 PURPOSE

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act, Chapter 718, Florida Statutes, as it exists on the date hereof\_as amended or renumbered from time to time (the "Act") for the operation of that certain condominium located in Pinellas County, Florida, and known as MANDALAY BEACH CLUB, a condominium. . . .

2. Adopted amendment to ARTICLE 10, to delete Section 10.4 of the Articles in its entirety, and to renumber all subsequent sections, as follows:

#### **ARTICLE 10 DIRECTORS**

10.4 Term of Developer's Directors. The Developer of the Condominium-shall appoint the members of the first Board of Directors and their replacements who shall hold office for the periods described in the By-Laws.
