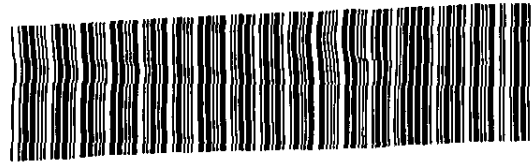

RESOLUTION

At the regular quarterly meeting, July 19, 1948, the Christian Science Society, a Florida non-profit Corporation, located at St. Cloud, Florida, the following motion was made by William J. Lawson, seconded by Iverine Huchlen, and resolved by unanimous vote:

WHEREAS, heretofore on the 24th day of March 1914, the Christian Science Society, St. Cloud, Florida, became a corporation not for profit, and its charter duly approved by the Judge of the Circuit Court in and for Osceola County, State of Florida, which charter is recorded, as of the 19th day of February, 1914, in Incorporation Book 2, page 90, and which is filed and re-recorded as of the 4th day of May, 1915, in Incorporation Book 2, page 160; and

WHEREAS, the Christian Science Society, aforesaid, has been operative and functioning under its corporate charter for the past thirty-four (34) years; and

WHEREAS, as the result of the united efforts of its members in accomplishing their common purposes as subscribed to the Tenets of The Mother Church Manual, this said Society has increased its membership; has grown financially, and otherwise expanded in its untiring efforts to effect these religious tenets and its corporate purposes; and

WHEREAS, this expansion and growth has been handicapped and limited by the charter as adopted in 1914; and

WHEREAS, the need to further expand, and the desire to further accomplish the purposes, ideals, and Tenets of The Mother Church is ever-present and inspiring; and

WHEREAS, the present charter adopted in 1914 is inadequate and otherwise limits the accomplishment of the present and future purposes aforesaid, and further limits the

progress of this Society because of the restrictions in the present charter as to the amount of indebtedness and amount of real property which can be held, the amendment, revision, and extension of the said charter becomes apparent and necessary.

2. To unite in common purposes and to dedicate ourselves to carry forth the work, spirit and goal of our inspired Discoverer and Founder of Christian Science, Mary Baker Eddy,

RESOLUTION TO AMEND CORPORATE CHARTER

At a duly called special meeting, this October 13, 1949 of the Christian Science Society, St. Cloud, Florida, a Florida non-profit corporation, located at St. Cloud, Florida, the following resolution to amend the corporate charter was presented and considered, whereupon, George Startzer moved for its adoption, the same being seconded by Helen DeVries, and it was resolved by unanimous vote, that:

WHEREAS, heretofore on the 24th day of March 1914, the Christian Science Society, St. Cloud, Florida, a branch of The Mother Church, The First Church of Christ, Scientist, in Boston, Massachusetts, became a corporation not-for-profit, and its charter duly approved by the Judge of the Circuit Court in and for Osceola County, State of Florida, which charter is recorded, as of the 19th day of February, 1914, in Incorporation Book 2, Page 90, and which is filed and re-recorded, as of the 4th day of May, 1914, in Incorporation Book 2, page 160; and said charter was amended, which was duly approved by the Judge of the said Circuit Court, State and County, aforesaid, and the said amendments filed and recorded, July 27, 1918, in Incorporation Book 3, page 291, all in the Public Records of Osceola County, State of Florida; and

WHEREAS, as the result of the united efforts of its members in accomplishing their common purposes as subscribed to the Tenets given in the Manual of The Mother Church, this Society has increased its membership, has grown financially, and otherwise expanded in its untiring efforts to effect its growth, these religious tenets, and its corporate purposes; and

WHEREAS, this Society succeeded in meeting the requirements of The Mother Church, The First Church of Christ, Scientist, in Boston, Massachusetts, and was therefore, on March 24, 1949, duly notified that it had met such requirements and that it had become First Church of Christ, Scientist, St. Cloud, Florida; and

WHEREAS, it is now necessary to amend the aforesaid existing charter to meet the present and future needs of the said church, in conformity with said achievements,

NOW, THEREFORE BE IT RESOLVED, that the aforesaid charter be hereby revised, extended and amended as follows:

AMENDMENTS TO CORPORATE CHARTER

I.

The name of this non-profit corporation is First Church of Christ, Scientist, St. Cloud, Florida, which is located at St. Cloud, Florida.

II.

5. To make and enter into contracts; to adopt and use a corporate seal and alter the same at pleasure; to make, adopt, change, amend and repeal the by-laws not inconsistent with the Constitution and Laws of the United States and of this State, and of The Mother Church Manual, with the exercise of its corporate powers, management, regulation and management of its property; to take, hold, sell and convey such property as shall be necessary in the amount authorized; to buy, hold, mortgage, sell or convey such property as purposes of this corporation shall require, and in the amount authorized.

III.

The membership of this Church shall consist of those persons who have subscribed to the Tenets of The Mother Church and to the charter and by-laws of this Church by having signed the book of membership. The manner of their admission shall be determined by the by-laws.

IV.

The term for which this corporation is to exist shall be perpetual.

VI.

The officers of this corporation, all of whom shall be members, and who shall manage its affairs in accordance with its By-Laws, are:

1. Board of Directors.

a. The Board of Directors shall consist of five members, and the manner of their election shall be by written ballot as provided in the By-Laws.

b. The Board of Directors shall elect a President and a Vice-President from its members.

c. The Board shall appoint such committees as may be deemed necessary to carry out the purpose of this Church.

2. Clerk.

3. Treasurer.

a. The Clerk and the Treasurer shall be elected by written ballot at the annual business meeting.

4. First Reader.

5. Second Reader.

a. The Readers (First and Second) shall be elected by written ballot at the annual business meeting, every third year, in accordance with the by-laws.

VII.

The present officers of this corporation shall manage the affairs until the next annual business meeting.

VIII.

The by-laws of this corporation may be amended, repealed, rescinded, altered, extended, or new ones adopted by the members in accordance with the by-laws.

IX.

The highest amount of indebtedness or liability to which this corporation may at any time subject itself which shall never be greater than two-thirds (2/3) of the value of the property held by the corporation at the time of such indebtedness or liability, shall be twenty-five thousand dollars (\$25,000.00). No real estate shall be sold, mortgaged, or transferred except by authority of the membership.

X.

The amount of value in real estate which this corporation may hold shall not exceed fifty thousand dollars (\$50,000.00).

BE IT FURTHER RESOLVED, that these amendments be submitted to the Judge of the Circuit Court in and for Osceola County, Florida, wherefore, this corporation respectfully moves for the approval of same.
