1. Name. The name of the company is GLANDORE TRADING US, LLC (the "Company").
2. Articles of Organization. The date of the filing of the Articles of Organization of the Company was October 12, 2016 (Document Number L16000188802).
3. Amendment. The Articles of Organization of the Company are hereby corrected effective as of October 12, 2016 as follows:

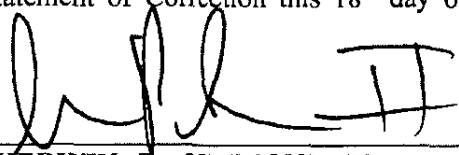
Article V is corrected with a new Article V is inserted in lieu thereof, to read as follows:

**ARTICLE V
MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of a manager or managers. Except as otherwise provided in the operating agreement of the Company, if any ("Operating Agreement"), the business and affairs of the Company shall be managed by or under the direction of the managers. The members may appoint one or more managers and grant them authority as specifically provided by statute or by the Operating Agreement. The initial manager shall be **Asgard Corporate Services, LLC**, whose address is **3615 E. Frontage Rd., Suite A, Tampa, FL 33607**.

4. Adoption of Correction. Pursuant to Section 605.0209 of the Florida Revised Limited Liability Company Act, the sole Member of GLANDORE TRADING US, LLC adopts this Statement of Correction. The foregoing correction to Article V was adopted and approved by the sole Member of the Company by written consent without a meeting. The written consent was sufficient for approval by sole Member.
