**ARTICLES OF INCORPORATION  
OF  
THE PSYCHOLOGY TEAM OF SOUTH FLORIDA, P.A.**

The undersigned incorporator hereby forms a professional corporation under Chapter 621 of the laws of the State of Florida.

**ARTICLE I - Name**

The name of the professional corporation is **The Psychology Team of South Florida, P.A.** (the "Corporation").

**ARTICLE II - Purpose**

The general purpose for which the Corporation is organized is to engage in every aspect of the practice of psychology. The professional services involved in the corporation's practice of psychology may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice psychology in the State of Florida.

The Corporation shall not engage in any business other than the practice of psychology. However, the corporation may invest its funds in real estate, mortgages, stocks, bonds and other types of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

**ARTICLE III - Capital Stock**

The Corporation is authorized to issue 1,000 shares of common stock, par value \$.001 per share. The Board of Directors may authorize the issuance of such stock to such persons upon such terms and for such consideration in cash, property or services as the Board of Directors may determine and as may be allowed by law. The just valuation of such property or services shall be fixed by the Board of Directors. All such stock when issued shall be fully paid and exempt from assessment.

**ARTICLE IV - Registered Office and Agent**
