

WHEREAS, the name of the company is River West SC, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on October 4, 2016 and assigned document number L16000184443; and

WHEREAS, the Members of the Company have recommended the amendments to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its Members and pursuant to the provisions of Section 608.411 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth effective as of the date of filing of these Articles of Amendment with the Division of Corporations;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization is hereby deleted and replaced with the following:

ARTICLE IV MANAGEMENT

The Company shall be managed by a Manager or Managers as provided in the Company's Operating Agreement. Effective immediately, the Manager of the Company shall be River West Manager, LLC, a Florida limited liability company, and it shall serve as such until replaced in accordance with the provisions of the Company's Operating Agreement.

- The date of the foregoing amendment's adoption was as of November 22, 2016.
- 3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
