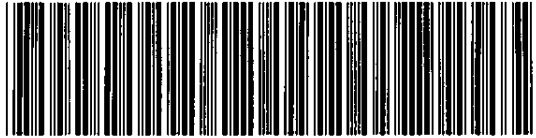

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The original articles of organization (the "Articles of Organization") of Segal & Rosenstein Dentistry, LLC, a Florida limited liability company (the "Company"), were filed with the Secretary of State of the State of Florida on March 6, 2015 and assigned Florida Document Number L15000041646.

In accordance with Chapters 605 and 621 of the Florida Statutes, the Articles of Organization of the Company are hereby amended and restated in its entirety to read as follows:

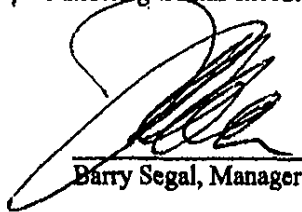
