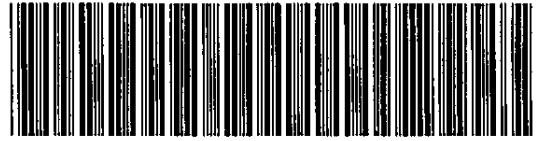




"ARTICLE I
