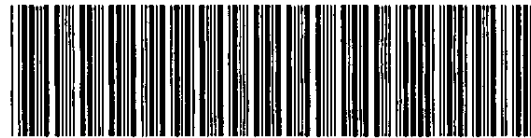

1275 WEST HEMINGWAY, LLC


