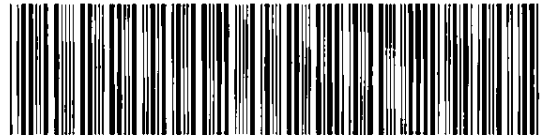

CERTIFICATE OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
BEACH MANOR VILLAS SOUTH, INC.

BEACH MANOR VILLAS SOUTH, INC. its address being c/o Keys Caldwell, Inc.,
1162 Indian Hills Blvd., Venice, FL 34293, Sarasota County, by the hands of the
undersigned hereby certify that:

The Declaration of Condominium of BEACH MANOR VILLAS SOUTH, a
condominium, is recorded in O.R. Book 841, page 232, of the Public Records of Sarasota
County, Florida. The following amendment to the Articles of Incorporation submitted to the
entire membership of the Association at its meeting called and held on the 9TH day of
January, 2017, and approved by affirmative vote in excess of 2/3rds of the total voting
interest of the Association as required by the Articles of Incorporation.

Article 10, Amendments, is hereby amended to read as follows:

~~10. Amendments. An affirmative vote of two-thirds (2/3) of the qualified voting members
of the corporation is required for the requested alteration, amendment or rescission.~~

10.1 Amendments. These Articles of Incorporation may be amended in the
following manner:

10.2 Notice. Notice of the subject matter of a proposed amendment shall be included in the members' meeting notice at which a proposed amendment is to be considered.

10.3 Resolution. A resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors or by not less than twenty (20%) percent of the Association's voting interest.

10.4 Adoption. These Articles of Incorporation can be amended, altered, or replaced only upon an affirmative vote of not less than 2/3rds the members who cast a vote, in person or by proxy, at a properly called members' meeting. Members not present in person at the members' meeting considering the amendment, may express their approval in writing, by proxy, provided their proxy vote is delivered to the Secretary prior to the members' meeting.

10.5 Amendments. All amendments shall be in the form prescribed by Section 718.112, Florida Statutes.

10.6 Execution and Recording. A copy of each amendment shall be attached to a certificate certifying that the amendment was duly adopted, which certificate shall be executed by two Association officers with all the formalities of a deed. A copy of each amendment shall be certified by the Secretary of the State of Florida. The amendment shall be effective when the certificate and copy of the amendment are recorded in the Public Records of Sarasota County, Florida.

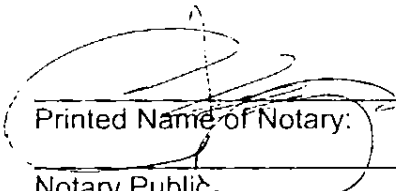
