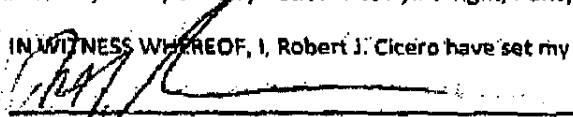
SPECIAL LIMITED POWER OF ATTORNEY

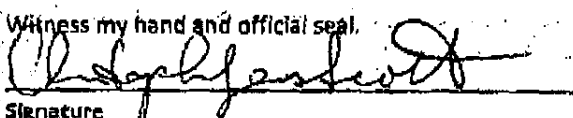

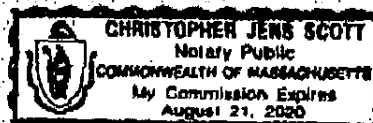
