ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MARTIN MEMORIAL HEALTH SYSTEMS, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes (2016), and the Corporation's Bylaws, Martin Memorial Health Systems, Inc., a Florida not-for-profit corporation (the "Corporation"), adopts the Amendment to its Articles of Incorporation set forth in paragraph 2, below:

- 1 The name of the Corporation is Martin Memorial Health Systems, Inc.
- 2: The Board of Directors of the Corporation resolved to amend the Articles of Incorporation of the Corporation at a special meeting of the Board of Directors of the Corporation held on the 23rd day of March, 2017, with a quorum being present, at which time the following amendment to the Articles of Incorporation was unanimously approved by the Board of Directors of the Corporation, viz.

"Article III of the Articles of Incorporation is hereby deleted and in lieu and place thereof, the following Article III is adopted:

ARTICLE III

NO MEMBERS

The Corporation shall have no members."

3. The members of Martin Memorial Health Systems, Inc. are not entitled, as members, to vote on proposed amendments to the Articles of Incorporation.
