## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

17170001079143

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the corporation is TOWN SHORES OF GULFPORT #209, INC.,
- 2. The following smeadments of the Articles of Incorporation were adopted by the Members as duly approved in the manner required therein, at a Members Meeting held on March 28, 2017 (additions indicated by <u>underlining</u>; deletions indicated by strike throughs, as follows):
  - A. Article VIII of the Articles of Incorporation
  - a. The Hy-Laws of the corporation are to be made, altered or rescinded by a two-thirds (2/3) voic of the members of this corporation, by a two-thirds (2/3) voic of the owners present and voting in person or by proxy at a shift called meeting at which a quorum is present.
  - B. Article XI

These Articles of Incorporation may not be amended, altered, modified, changed or rescinded by a vote of less than a two-thirds (2/3) vote of the owners present and voting in person or by proxy at a duly called meeting at which a quorum is present of the then present members of the corporation, which may be accomplished at any regular or special accering of the corporation, provided that written notice of the proposed change shall have been mailed to each member of the corporation ten (10) days prior to said meeting of the corporation, provided, however, that no such alteration, amendment, mulification, change or rescission of Article II hereinabove, and of Section 4, 5, 5 and 8 of Article X may be made without the unminimous approval of the then members of the corporation together with the written unanimous approval of all mortgagees holding a valid, enforceable first mortgagees, such as a bank savings and loan association or insurance company, authorized to transact business in the State of Florida.
