Amend ARTICLE III - Purpose to remove the words "animal welfare" on line 1 so the Article now reads as follows:

This corporation is organized exclusively for charitable, educational, and scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of this corporation is:

1. - to support and conduct scientific research, education, and informational activities to increase the understanding of aquatic animals, their environment, human impacts on aquatic animals and their environment, and conservation of aquatic animals and their environment;

2. - to support and conduct rescue and rehabilitation efforts on injured or compromised aquatic animals.
