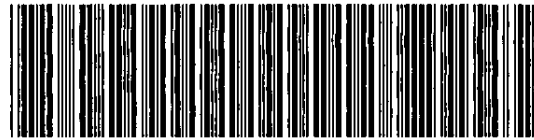

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is JMG Capital Holdings 5, LLC.

The existence of the Company shall commence on the date these Articles of Organization are


