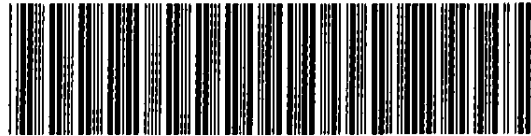

The purpose for which this Limited Liability Company is organized is for any lawful purpose; provided, however, that this Limited Liability Company shall not, directly or indirectly: engage in any lobbying of the Florida Department of Environmental Protection; engage in any business for or on behalf of the Florida Department of Environmental Protection; engage as an employee, agent or subcontractor, any person who is employed by the Florida Department of Environmental Protection; knowingly work for any person or entity who is engaging in business with or has any business pending before the Florida Department of Environmental Protection; provide any services or goods of any kind to the Florida Department of Environmental Protection; or, knowingly accept any gift from any person or entity who lobbies, is a vendor for, is regulated by, or who has business with, the Florida Department of Environmental Protection, or who is a political committee as defined in s. 106.011, F.S.
