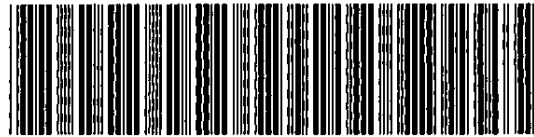

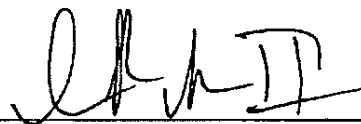
ARTICLE X

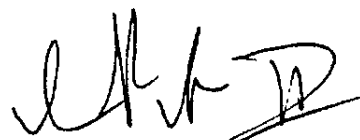
