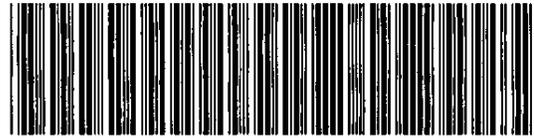

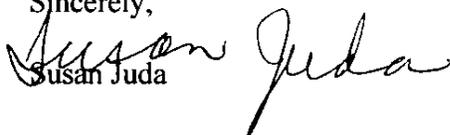

Article I.
NAME

The name of the Corporation is: Sarasota Stands Together, Inc.

Article II.
PRINCIPAL OFFICE & MAILING ADDRESS

The principal office of the Corporation and its mailing address shall be as follows: 1770 Benjamin Franklin Drive, Apt. 12C, Sarasota, FL 34236.

Article III
PURPOSE

The Corporation is not organized for profit; it shall have no capital stock and shall not be authorized to issue capital stock. The purposes for which the Corporation is formed are:

- 1) To create a networked community of empowered non-partisan action oriented individuals who work to protect the well-being and equality of all citizens and who support the election of candidates that defend human rights and our democracy.
- 2) To do any or all other lawful business which non-profit corporations may do under Florida law.
