



The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida statues, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

Article I – Name of Corporation

The name of this corporation shall be 4 Jesus Ministries, Inc.

Article II. Address of Principle office and Mailing Address of Corporation.

The address of the principle office and mailing address of the corporation is: 1222 Creekbottom Circle, Orlando, FL. 32825.

Article III - Purposes and Powers of Corporation

- A. 4 Jesus Ministries, Inc. is organized exclusively for charitable, religious, educational, and/or scientific purposes, included, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. "To the extent consistent with the preceding sentence and permissible under Florida Law, the purposes of this corporation shall include, but shall not be limited to unify the body of Christ in establishing the kingdom of God on Earth through worship, prayer, and the proclamation of the good news which heals the sick and the brokenhearted, and sets the captives free.
- B. This corporation shall be authorized to carry out any and all acts and to exercise any and all corporate powers which may now or hereafter be lawful under the laws of the State of Florida to the extent applicable to corporation not for profit and that are not inconsistent with these Articles of Incorporation.
- C. Notwithstanding anything contained in these articles of incorporation to the contrary, the following provision shall apply:
 - No part of the net earnings of the corporations shall inure to the benefit of, or be
 distributable to its members, trustees, officers, or other private persons, except that the
 corporation shall be authorized and empowered to pay reasonable compensation for
 services rendered and to make payments and distributions in furtherance of the
 purposes set forth in Article Third hereof."
 - 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall

not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 4. If the corporation is, or shall ever be, classified as a "private foundation", as defined in section 509(a) of the code, the following provision shall apply for so long as it remains a private foundation:
 - (I) The corporation will not engage in any act of self-dealing as defined in section 4941 (d) of the code.
 - (II) The corporation will distribute its income for each tax year at such time and in such manner, as not to become subject to the tax on undistributed income imposed by section 4942 of the code.
 - (III) The corporation will no retain any excess business holdings as defined in section 4943 © of the code.
 - (IV) The corporation will not make any investment in such a manner as to subject it to tax under section 4944 of the code.
 - (V) The corporation will not make any taxable expenditures ads defined in section 4945 (d) of the code.
