#### ARTICLES OF INCORPORATION

OF

# SOUTHWEST FLORIDA FINANCIAL LITERACY FOUNDATION, INC., a Florida Not For Profit Corporation

The undersigned officer of SOUTHWEST FLORIDA FINANCIAL LITERACY FOUNDATION, INC., a Florida not-for-profit corporation (the "<u>Corporation</u>"), for the purpose of forming a nonprofit corporation under the Florida Not-For-Profit Corporation Act, Florida Statutes Chapter 617, makes and adopts the following articles of incorporation (the "<u>Articles</u>"):

### ARTICLE 1. NAME

The name of the corporation is: SOUTHWEST FLORIDA FINANCIAL LITERACY FOUNDATION, INC.

### ARTICLE 2. ADDRESS

The street address of the principal office of the Corporation is: 1250 Tuna Court, Naples, Florida 34102. The mailing address of the Corporation is: 1250 Tuna Court, Naples, Florida 34102.

### ARTICLE 3. REGISTERED OFFICE AND AGENT

The street address of the registered office of the Corporation is: 1250 Tuna Court, Naples, Florida 34102. The name of its registered agent at that address is: Nicholas A. Carr, PH.D.

#### ARTICLE 4. NO MEMBERS

The Corporation shall have no members.

### ARTICLE 5. PURPOSE

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including but not limited to, EDUCATING AND

RAISING AWARENESS FOR FINANCIAL LITERACY, and to conduct any and all lawful business ordinarily conducted by a not-for-profit corporation, in accordance with the laws of the State of Florida.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article 5.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### ARTICLE 6. **DURATION**

The duration (term) of the Corporation is perpetual.

# ARTICLE 7. DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed to one or more faith based nonprofit organizations with exempt purposes as defined in section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE 8. BOARD OF DIRECTORS

There shall be a Board of Directors consisting of not less than three (3) individuals. The directors are as follows:

Directors shall be elected or removed in the manner and at the times set forth in the Corporation's bylaws.

# ARTICLE 9. OFFICERS

The officers of the Corporation may consist of a president, one or more vice presidents, a secretary, a treasurer, and any other officers and assistant officers as may be provided for in the bylaws or by resolution of the Board of Directors. Each officer shall be elected or removed at such a time and in such a manner as may be prescribed by the bylaws or by law.
