ARTICLES OF INCORPORATION
OF
ART IN ALL MEDIUMS, INC.
a not-for-profit corporation

ARTICLE I

Name

The name of the Corporation is Art In All Mediums, Inc. (the "Corporation").

ARTICLE II

Principal Office

The principal office and mailing address of the Corporation is:

ARTICLE III

Purposes and Powers

(a) The Corporation is organized for the exclusive purposes of (i) producing and selling artworks with the net proceeds to be donated to religious and other charitable organizations, and (2) other non-profitable purposes for which corporations may be organized under the Florida Not-For-Profit Corporation Act and which the Board of Directors may deem to be in the best interests of the Corporation.

(b) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in this Article.

(c) Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

(d) The Corporation shall have all the powers conferred upon a corporation under the provisions of the Florida Not-For-Profit Corporation Act, Chapter 617, Florida Statutes, and any enlargement of such powers conferred by subsequent legislative acts, and shall have all powers necessary, proper, convenient, or desirable in order to fulfill and further the purposes of the Corporation.

ARTICLE IV

Board of Directors

4.1 Number. The powers of the Corporation shall be vested in the Board of Directors. The number of directors may be increased or decreased pursuant to the Bylaws of the Corporation, but shall never be less than one (1). The directors shall be elected pursuant to such procedures as are specified in the Bylaws.
