Operating Agreement

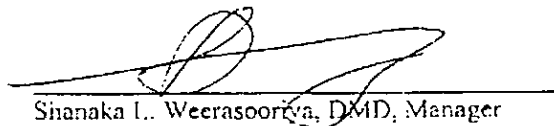

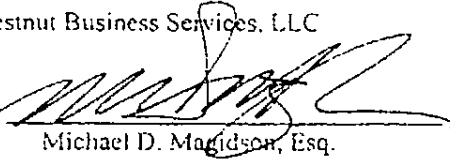
