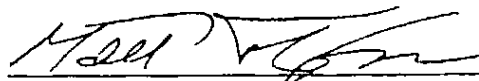
ARTICLE IV

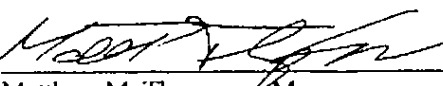
