ONE. The name of this corporation is Global Tel*Link Corporation (the "Corporation").

TWO. The name of the Corporation's initial commercial registered agent is Corporation Service Company, with an address of 12550 W. Explorer Drive, Suite 100, Boise, Idaho 83713.

THREE. The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the provisions of the Idaho Business Corporation Act, Title 30, Chapter 29 of the Idaho Code.

FOUR. The total number of shares of stock which the Corporation shall have authority to issue is One Hundred Thousand (100,000), consisting of One Hundred Thousand (100,000) shares of common stock, \$0.01 par value per share.

FIVE. The Corporation is to have perpetual existence.

SIX. The number of directors which constitute the whole board of directors of the Corporation (the "Board of Directors") shall be as specified in the bylaws of the Corporation (the "Bylaws").

SEVEN. Meetings of stockholders may be held within or without the State of Idaho, as the Bylaws may provide. The books of the Corporation may be kept (subject to any provision contained in the statutes) outside the State of Idaho at such place or places as may be designated from time to time by the Board of Directors or in the Bylaws of the Corporation.

EIGHT. Advance notice of new business and stockholder nominations for the election of directors shall be given in the manner and to the extent provided in the Bylaws of the Corporation. Elections of directors need not be by written ballot unless the Bylaws of the Corporation shall so provide.

NINE. The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted subject to this reservation.

TEN. To the fullest extent permitted by applicable law as it presently exists or may hereafter be amended, no director of the Corporation shall be personally liable to the Corporation or its shareholders, for money damages for any action taken, or any failure to take any action, as a director. No amendment to, modification of or repeal of this paragraph Ten shall apply to or

have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to such amendment.

ELEVEN. The Corporation shall indemnify, advance expenses, and hold harmless, to the fullest extent permitted by applicable law as it presently exists or may hereafter be amended, any person (a "Covered Person") who was or is made or is threatened to be made a party or is otherwise involved in any action, suit or proceeding, whether civil, criminal, administrative or investigative (a "Proceeding"), by reason of the fact that he or she, or a person for whom he or she is the legal representative, is or was a director or officer of the Corporation or, while a director or officer of the Corporation, is or was serving at the request of the Corporation as a director, officer, employee or agent of another corporation or of a partnership, joint venture, trust, enterprise or nonprofit entity, including service with respect to employee benefit plans, against all liability and loss suffered and expenses (including attorneys' fees) reasonably incurred by such Covered Person. Notwithstanding the preceding sentence, except for claims for indemnification (following the final disposition of such Proceeding) or advancement of expenses not paid in full, the Corporation shall be required to indemnify a Covered Person in connection with a Proceeding (or part thereof) commenced by such Covered Person only if the commencement of such Proceeding (or part thereof) by the Covered Person was authorized in the specific case by the board of directors of the Corporation. Any amendment, repeal or modification of this paragraph Eleven shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

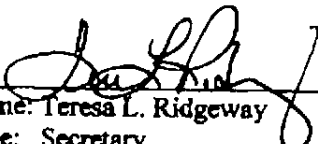
