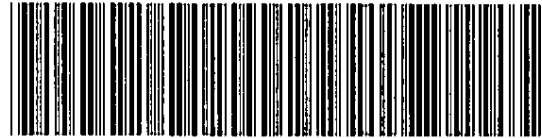


**ARTICLES OF AMENDMENT

4. The amendment of the article of organization was approved by all members on August 15, 2017. The number of votes cast for the amendment was sufficient for approval.



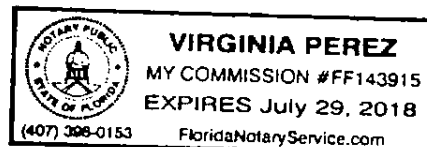
