ARTICLE V**Management of Business**

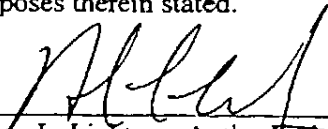

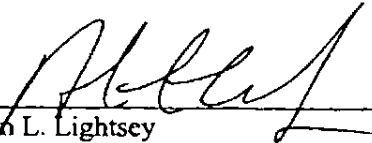
