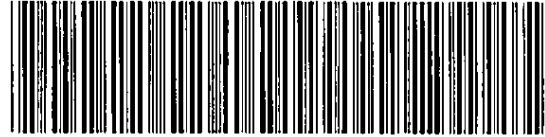



Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation as subsequently amended is amended to read:


ARTICLE I - NAME

*The name of this Corporation is **Tallahassee Pulmonary Clinic, P.A.***

2.
