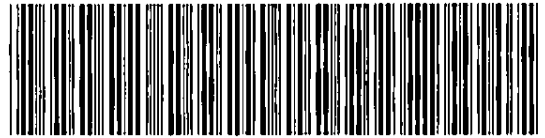

Pursuant to 605.1025 , Florida Statutes relating to mergers, the undersigned hereby certifies as follows:

FIRST: The name of the merging entity is as follows:

SAFE-BioPharma Association, a Delaware Exempt Corporation ("SBP").

SECOND: The name of the surviving entity is as follows:

NH-ISAC Acquisition, LLC, a Florida limited liability company ("NH-ISAC Acquisition").

THIRD: The merger was approved by NH-ISAC Acquisition in accordance with ss. 605.1021-605.1026, and by SBP in accordance with the applicable provisions of the Delaware General Corporation Law.

FOURTH: The surviving entity is an entity that exists before the merger and is a domestic filing entity, with no amendment to its public organic record.

SIXTH: The merger is to become effective on 12:01am January 1, 2018.

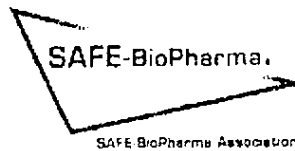
