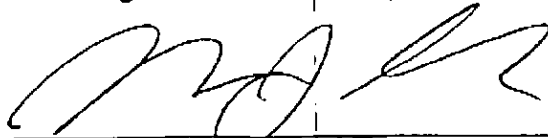
**ARTICLE III

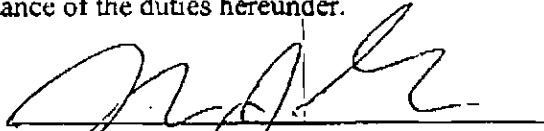
