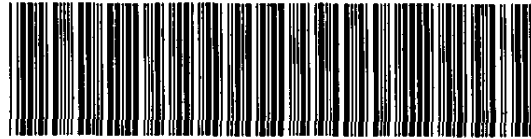

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
DADESYSTEMS, INC.**

DADESYSTEMS, INC., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act (the "Act"): 2018 APR -4

1. The Company hereby increases the number of authorized shares of its Series A Preferred Stock from 28,051 shares to 48,051 shares, and, to reflect such increase, hereby amends and restates the first sentence of Section C of Article IV of the Articles of Incorporation of the Corporation as follows:

**C. Designation of Series A Preferred Stock**

The Corporation hereby creates a class of authorized preferred stock, par value \$1.00 per share, consisting of 48,501 shares, designated as Series A Preferred Stock (the "Series A Preferred"), which shall have the following rights, preferences, privileges:

2. These Articles of Amendment were approved by unanimous Written Consent of the Directors and Shareholders of the Corporation, and such approval was sufficient to approve these Articles of Amendment under the Act and the Articles of Incorporation and Bylaws of the Corporation.

3. These Articles of Amendment shall become effective as of the close of business on the date of the filing of these Articles of Amendment with the Secretary of State of State of Florida.
