**ARTICLES OF AMENDMENT
TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
VIVEK WELFARE AND EDUCATIONAL FOUNDATION, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Vivek Welfare and Educational Foundation, Inc.
(hereinafter referred to as the "Corporation").

ARTICLE II - TEXT OF AMENDMENTS

Article I of the Articles of Incorporation is amended by replacing it in its entirety with the following:
