

The following is an amendment to the Articles of Incorporation of Town Shores of Gulfport, No. 209, Inc., as originally recorded at Official Records Book 3619, Page 1919, et. seq. of the Public Records of Pinellas County, Florida, and as amended, including being re-recorded at Official Records Book 17110, Page 2415, et. seq. of the Public Records of Pinellas County, Florid.

New Wording <u>Underlined</u>; Deleted Wording Stricken Through (Except when proposed amendment involves substantial rewording).

Article X, Section 2 is amended to read as follows:

Each member shall be restricted to one (I) vote, except in all elections for directors, each member shall have the right of cumulative voting that is to say, each member shall have the right to vote, in person or by proxy, for as many persons as there are directors to be elected, or to distribute them on the same principle among as many candidates as he shall see fit. to vote in person or by proxy for the number of open director positions utilizing one vote per candidate. Cumulative voting (more than one vote for a candidate) is not allowed.
