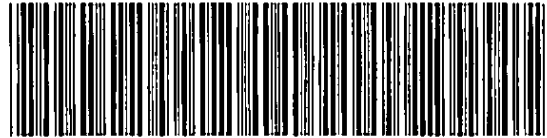

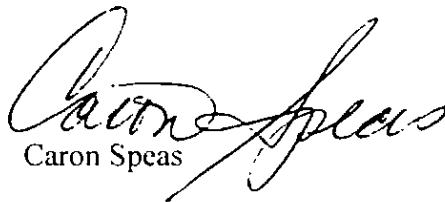

**Amended Articles of Incorporation
of
Music Lessons, Inc.**

In compliance with the requirements of F.S. Chapter 607, Music Lessons, Inc., by and through its sole Director and Shareholder, being a natural person, hereby adopts, approves and files this Amended Articles of Incorporation:

Article I - Name

The name of the corporation shall remain Music Lessons, Inc.

Article II - Principal Office

The principal place of business/ mailing Address is 2419 Crill Avenue, Palatka, FL 32177.

Article III - Purpose

The purposes for which this corporation is formed are for the operation of a music school and for the sale of musical instruments, accessories, and supplies, and any and all related manner of business, and to engage in any activities or business permitted under the laws of the United States and Florida.

Article IV - Shares

The maximum number of shares the corporation is authorized to issue is one thousand (100) shares, all of which shall be common shares and shall have a par value of one dollar (\$1.00). The corporation shall have perpetual existence.

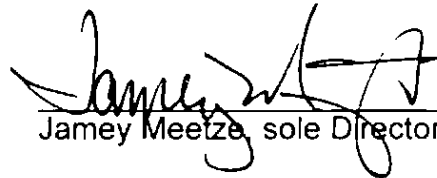
Article VIII - Board of Directors
