

## MANAGEMENT



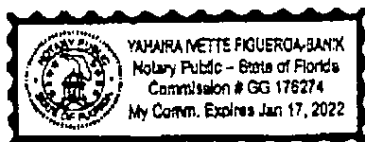


