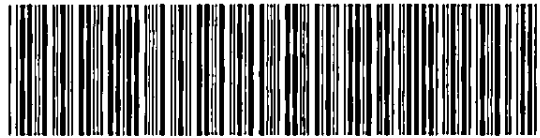

FIRST: The following Article I is hereby amended to read as follows:


ARTICLE 1 – NAME


The name of the corporation is **COLLINS BROWN BARKETT, CHARTERED.**
