**FIRST:** The name of the Corporation is **UNITED WAY OF BROWARD COUNTY, INC.**

**SECOND:** The Articles of Incorporation of the Corporation are hereby amended by deleting subparagraphs (2) and (3) of Article VIII thereof as they now exist, and Article VIII of the Articles of Incorporation is hereby amended in its entirety to read as follows:

**"ARTICLE VIII - GENERAL**


(1) This Corporation is a not-for-profit Corporation having no capital stock. Its assets include gifts, bequests, devises and grants.

(2) This Corporation shall have perpetual existence."


