## ARTICLES OF ORGANIZATION OF OCAQUATICS 5, LLC

The undersigned organizer, who is the authorized representative of the initial Member and Manager of Ocaquatics 5, LLC, a Florida limited liability company (the "Company") under the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization (the "Articles").
