ARTICLES OF INCORPORATION
OF
1 FUTURE CORPORATION.

Article I - Name

The name of this corporation is **1 Future Corporation.**

Article II- Duration

This corporation shall have perpetual existence.

Article III- Purposes

The purpose of the Corporation is as follows:

A. This corporation is a non-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

i) To offer tutoring services to underprivileged students in Miami-Dade County, Florida

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporation.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporation under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers, but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its purposes.

Article IV- Initial Registered Office and Agent

Article V- Initial Board of Directors

The initial Board of Directors shall have 3 (three) Directors whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than 3 (three).

Article VIII Nonstock basis. The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not for Profit Corporation Act, and shall not have power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the bylaws.

Article IX- Distribution of Assets Upon Dissolution of the Organization

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

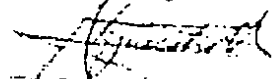
