



ARTICLES OF ORGANIZATION OF BADASS SPICES LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is BadAss Spices LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address of the Company, and the street address of the principal office of the Company, is 1041 Crown Park Circle, Winter Garden, Florida 34787.

ARTICLE III - DURATION
