



Section E - Amended and Added Articles for Aviation Kids USA, Inc.

Amend Article III to state:

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of this corporation is:

- 1. Promote aviation education and career opportunities in America.
- 2. Support general aviation and STEM education.
- 3. Increase public awareness of aviation technologies.
- 4. Provide a non-profit charitable organization to support the above activities.

Add Article IX - Exemption Requirements:

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

- 1. No part of net earnings of the organization shall inure to the benefit of, or be distributable to its trustees, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
- 2. No substantial part of the activities of the corporation shall constitute the carry on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or Intervene in (including by publication or distribution of statements,) any political campaign on behalf of, or in opposition to any candidate for public office.
- 3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c) (3) or the Internal Revenue Code or corresponding section of any future tax code, or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.

Add Article X - Membership/Board of Trustees

This corporation shall have no members.

The management of the affairs of the corporation shall be vested in a board of trustees, as defined by the corporation's bylaws. No director shall have any right, title, or interest in or to any property of the corporation.

Add Article XI - Personal Liability

No officer, or trustee of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or trustees be subject to the payment of the debts or obligations of this corporation

Add Article XII – Duration/Dissolution

The duration of the corporate existence shall be perpetual until dissolution.

Upon the dissolution of the organization, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose.
