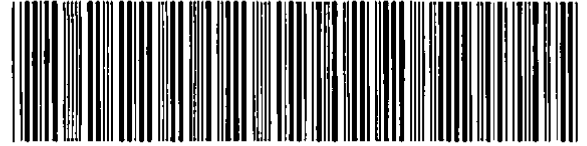

ARTICLES OF ORGANIZATION
