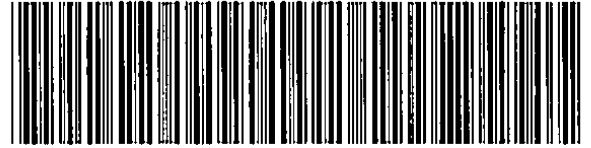

We had received a letter (#019A00011441) that the Foreign Entity Application submitted had a few requirements that needed to be satisfied before it could be approved:

- 1) File an annual report
- 2) Pay a fee and penalty of \$1,887.50
- 3) Send an original copy of a Certificate of Good Standing

When I read this letter I was confused, since Modani Holdings LLC, the foreign entity being created, was started in May of 2019 and therefore there would be no prior years of business transacted in the state of Florida.

I must apologize, upon review of the original application I had put down 01/16/2009 as the start date and that date was incorrect. To explain: Modani Holdings LLC, a Florida LLC was created on 01/16/2009. In April 2019, Modani Holdings LLC (the Florida Corporation) was converted to a Delaware Corporation (please reference the paperwork I sent with the original application). Since Modani Holdings LLC was now a Delaware Company, a new foreign entity had to be created in Florida: thus the foreign entity application for Modani Holdings LLC. Unfortunately, I entered the wrong date on the application and instead of placing May 2019, I entered 01/16/2009.





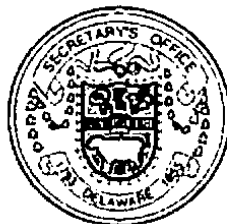
