## **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The general nature of the professional services to be rendered by this professional services corporation are:

- a. To engage in every aspect of the business of rendering the same professional services to the public that an attorney licensed under the laws of the State of Florida is authorized to render. These professional services shall be rendered only through officers, employees, and agents who are licensed under the laws of the State of Florida to provide such services.
- b. To buy, sell, deal in, and exchange shares of its own capital stock, except that the corporation shall not issue any of its capital stock to anyone other than an individual who is licensed or otherwise legally authorized to render professional services within the State of Florida. No shareholder of the corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock.
- c. To invest the funds of the corporation in real estate, mortgages, stock, bonds, or any other type of investment, and to own real and personal property necessary to render professional services.
- d. To do everything that is necessary and proper to accomplish the purposes enumerated in the Articles of Incorporation, whether alone or in association with other corporations, firms, or individuals.
- c. The corporation shall have all of the powers which are now, or which may in the future be, conferred upon professional service corporations by the laws of the State of Florida.
