ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MAGNOLIA BAY CONDOMINIUM ASSOCIATION OF BREVARD, INC.

As used herein the following shall apply:

- 1. Article III.B.6 of the Articles of Incorporation of Magnolia E Condominium Association of Brevard, Inc. shall be amended to read as follows:

"ARTICLE III

POWERS

- B. All of the powers reasonably necessary to implement and effectuate the purposes of the Association, including, but not limited to:
- 6. To acquire title to property or otherwise hold, convey, lease, and mortgage association property for the use and benefit of its members. The power to acquire personal property shall be executed by the Board of Administration. Except as otherwise permitted in subsections (8) and (9) of Section 718.111, Florida Statutes, and in Section 718.114, Florida Statutes, no association may acquire, convey, lease or mortgage association real property except in any manner provided in the declaration, and if the declaration does not specify the procedure, then approval of 75 percent of the total voting interests shall be required. Notwithstanding the foregoing to the contrary, the

Association's previous acquisition of title to the 20 Condominium Units situated within what was added as Phase Four a/k/a Phase 4 to the Condominium by the developer is hereby approved and ratified by the Association retroactive to the date the Association acquired such real property (hereinafter defined as 'Association Property')."
