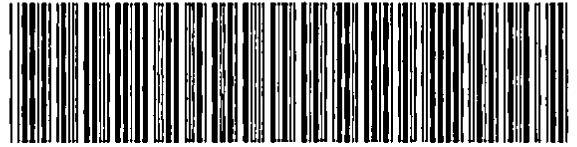

AMENDMENT TO ARTICLE III TO READ AS FOLLOWS:

The specific purpose of which this corporation is organized is:

501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be
carried on by an organization exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code or
the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning
of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be
distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed
of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization
is then located, exclusively for such purposes or to such organization is the located, exclusively for such purposes or to such
organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
