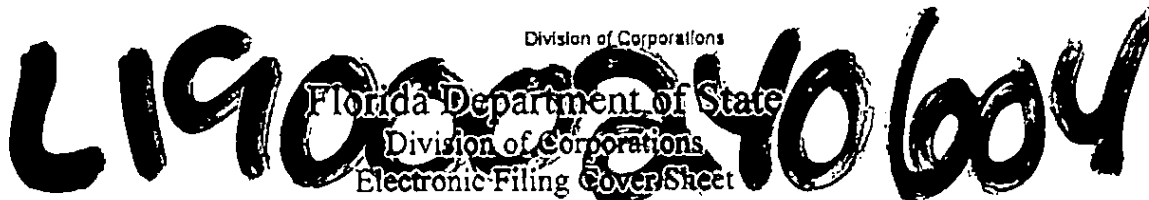

**ARTICLES OF AMENDMENT TO

Management of the Company


