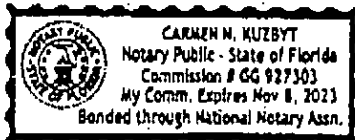

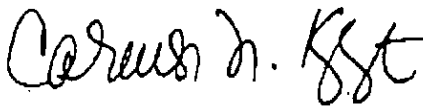

Purpose**

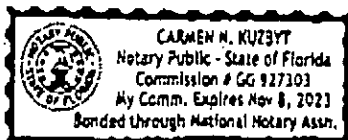
The purpose for which the Corporation is organized is to engage in any and all lawful business permitted under the Florida Business Corporation Act.
