ARTICLE I - Name

ARTICLE IX - *Admission of New Members*

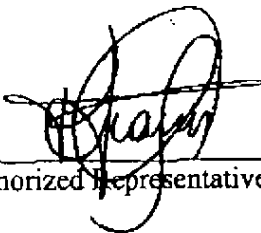

ARTICLE X - Dissolution
