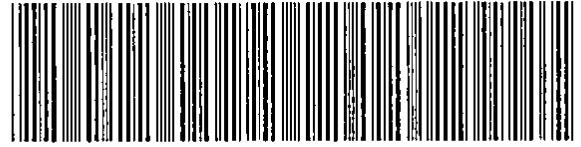



ARTICLE X - AMENDMENT

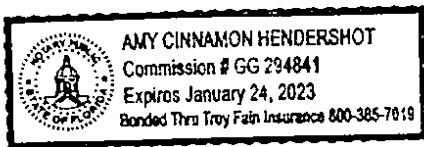



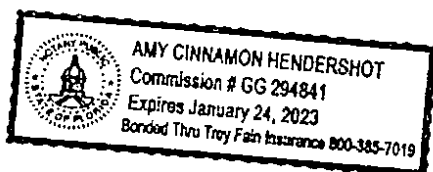
