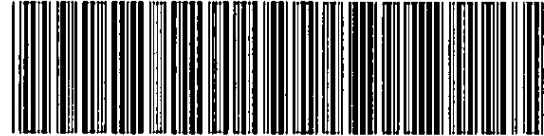

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation, for profit, generally, and hereby make and subscribe, acknowledge, and file this Certificate for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I.

Name of Corporation

The name of this Corporation shall be: DONALD W.
MCINTOSH ASSOCIATES, INC.

ARTICLE II.

General Nature of Business

The general nature of the business to be transacted by this Corporation shall be:

(a) To perform acts of land surveying in connection with the establishing and re-establishing of boundaries of tracts of land.

(b) To engage in land use planning and to subdivide, plat, improve and develop lands and engage in all things needful and lawful for the development and improvement of same for residence, trade or business and for sale or otherwise.

(c) To carry on and conduct a general construction business including the designing, constructing, enlarging,

extending, repairing, completing, removing, or otherwise engaging in any work upon power plants, industrial plants, and other systems and works of every description, buildings, structures, manufacturing plants, and all kinds of excavation, and iron, steel, wood, masonry, mechanical, electrical, and earth construction and installations, to make, execute, and take or receive any contracts or assignments of contracts therefor or relating thereto or connected therewith; and to manufacture or otherwise acquire and furnish all buildings and other materials and supplies connected therewith or required therefor; to manufacture, produce, adapt, and prepare, deal in and deal with any materials, articles, or things incidental to or required for, or useful in connection with any of its business, and generally to carry on in conjunction with and incidental to any of the matters aforesaid.

(d) To apply for, acquire, buy, sell, assign, lease, pledge and mortgage or otherwise dispose of letters patent of the United States or of any foreign country, and all or any rights, territorial or otherwise, thereunder. To apply for, acquire, hold, sell, assign, lease, mortgage, or otherwise dispose of patent rights, licenses, privileges, inventions, secret processes, trademarks, trade names, and pending applications thereof, relating to or useful in connection with any business of the corporation. To use, manufacture, or grant licenses under any letters patent, owned or controlled by the company, and to expend money in experimenting upon and testing the validity or value of any patent rights the company may acquire or proposes to acquire.

(e) To acquire, own and hold such real and personal property as may be necessary and convenient for the transaction of its business, and any interest therein, and to establish and carry on any business which may seem calculated to enhance

the value of the property or rights of the corporation, or to facilitate the disposition thereof; to survey, plat, subdivide, improve, sell, manage, lease, mortgage, dispose of, turn to account, or otherwise deal with all or any part of such property.

(f) To underwrite, subscribe for, purchase, hold, assign, pledge and otherwise dispose of capital stock, mortgages, bonds, debentures, notes, securities, obligations and contracts and evidence of indebtedness of any corporation and to issue in exchange therefor its stock, bonds, or other obligations and considerations, and to act as general underwriters.

(g) To advance or lend, and borrow money, and execute, deliver, accept, take and receive notes, bonds, debentures, or other evidences thereof, and mortgages, trust deeds, pledges or other securities for the payment of same; to negotiate loans; to offer for public subscriptions or otherwise aid or assist in placing any securities, stocks, bonds, or other investments, and to give any guarantee in relation to any investments issued by or acquired and sold or disposed of by or through this Corporation. To act as agents, brokers and commission men in the buying and selling of stocks, bonds, mortgages, debentures, securities and obligations of every character and nature whatsoever, and to subscribe for the issuance of stocks, bonds, mortgages, debentures, securities and other obligations and to sell or otherwise dispose of any such issue or issues.

(h) To form, promote, and assist financially or otherwise, companies, syndicates and associations of all kinds, and to give any lawful guarantee in connection therewith or otherwise for the payment of money, or for the performance of any obligations or undertaking. To become party to any lawful agreement for sharing of profits, or to any union of interest, cooperation or mutual agreement with any person, firm, corporation or company carrying on or engaged in any business

connected with or similar to the business of this Corporation, or in which this company is or is about to become interested financially or otherwise, and to lend money or otherwise assist any such person, firm or corporation, and to take or otherwise acquire and hold shares of stock in or securities or obligations of any such person, firm or company, and to sell, hold, re-issue or otherwise deal with such shares, stocks, securities or obligations.

(j) To do all, and everything necessary, suitable, convenient and proper for the accomplishment of any of the purposes enumerated in this Certificate of Incorporation, or any amendment thereof, or for the attainment of any or all of the objects herein enumerated or incidental to the powers herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation, either as holders of or interested in any property or otherwise, and in general to carry on any lawful business necessary

or incidental to the attainment of the objects of the corporation, whether or not such business is similar to the objects set forth in this Certificate of Incorporation or any such corporation or any amendment thereof, with all the powers now or hereafter conferred upon corporations by the laws of Florida.

The business of this Corporation is, from time to time, to do any one or more or all of the acts and things set out herein, and it shall have the right to conduct its business in all of its branches, in or outside of the State of Florida, or in any other State, Territory or Dependency of the United States of America, or in foreign countries, it being the intention that each of the objects, purposes and powers specified in all of the provisions of this statement of purposes shall be regarded as independent objects, purposes and powers and to be in no manner, or to any extent limited or restricted by reference or inference by or from the terms of any clause of this statement, or any other paragraph of this Certificate of Incorporation and Charter.

ARTICLE III.

Capital Stock

The capital stock of this Corporation shall consist of one hundred (100) shares, without nominal or par value; the Board of Directors may, from time to time, fix and determine the consideration for which the authorized shares, without nominal or par value, may be issued or disposed of by the corporation.

ARTICLE IV.

Amount of Capital With Which to Begin Business

The amount of capital with which this Corporation shall begin business is ONE THOUSAND DOLLARS (\$1,000.00).

ARTICLE V.

Corporate Existence

This Corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE VI.

Principal Place of Business
