FOR  
HER VOICE FOUNDATION, INC.**

Pursuant to Florida Statutes, Section 617.0202, the undersigned subscriber hereby adopts the following Articles of Incorporation to form a not for profit corporation:

**ARTICLE I  
Name**

The name of this Corporation is: HER VOICE FOUNDATION, INC.

**ARTICLE II  
Address**

The principal office and mailing address of this Corporation is: 460 Marmora Avenue, Tampa, Florida 33606. The Board of Directors may from time to time designate such other post office address and place for the principal office of this Corporation as it may see fit.

**ARTICLE III  
Objective and Purpose**

This Corporation shall be non-profit, non-political and non-sectarian and shall take no position in matters of government policies other than those concerning individuals who are female victims or survivors of a violent crime. The purpose of this Corporation shall be to:

Work to provide victim/survivor advocacy services for female victims of violent crimes across the United States. The primary goal of our program is to offer support, information and direction for those women victim and survivors of violent crimes.


